Subject: Travel Reimbursement for Board-related business

CareerSource Heartland (CSH) has an approved Travel Reimbursement Policy for Board members who travel for official board-related business. Board members who do not routinely receive travel reimbursement from another source are eligible for CSH mileage reimbursement at the rate currently authorized by Florida Statutes which, as of this date, is \$.445/mile. Members can be paid for highway mileage from the city in which their travel originated, to the city at which the Board or committee meeting was held, on a round-trip basis (generally utilizing a web-based mileage program to determine mileage between the two points of travel). Members cannot be reimbursed for travel within a respective city.

Our Board meeting sign-in sheet has a check box on each member's signature line. Board members interested in receiving mileage reimbursement to a CSH Board or committee meeting should check that box, thereby indicating that reimbursement is being requested.

Following the meeting, staff will process the travel request for payment, which normally occurs within ten working days.

# **Board Member Rotation: Economic Development and Education**

As part of new state legislation effective July 1, 2012, the "Workforce Accountability Act" required regional workforce boards to reduce the size of their membership to that suggested by the state workforce board CareerSource Florida (then Workforce Florida, Inc.).

To be compliant with the new law\*, one Economic Development position and two School District positions, along with one private-sector position, were removed from our board membership, and a "rotating" schedule of our counties economic development and education membership/representation was proposed and approved by our Board. The original rotation schedule expired June 30, 2018. The schedule has been updated to reflect the rotation for the next four years. Only the program years were updated. No other changes were made.

The following represents the updated rotation schedule, effective July 1, 2023.

# **CareerSource Heartland Board of Directors Private Education or Training Provider Seat**

Each local workforce development board (LWDB) must include representatives of entities administering education and training activities in the local area. A private education or training provider must be included if a public education or training provider is represented on the LWDB. The CareerSource Florida (CSF) Board of Directors may waive this requirement if requested by a LWDB when it is demonstrated that such representative does not exist in the local area.

This document outlines the process by which local private education or training providers will be identified, and the efforts to be taken to include a representative of this category on the CareerSource Heartland (CSH) Board of Directors.

#### Background

Section 122 of the Workforce Innovation and Opportunity Act states that eligible education/training providers must meet one of the following:

- An institution of higher education and provide a program(s) that leads to recognized post-secondary credential; or
- An entity that carries out apprenticeship programs registered under the National Apprenticeship Act (NAA); or
- Other public or private providers of training service programs which may include joint labor-management organizations, pre-apprenticeship programs, and occupational/technical training; or
- A provider of adult education and literacy under Title II if such activities are provided in combination with occupational skills training.

#### **Process**

When the Private Education or Training Provider seat on the CSH Board of Directors becomes vacant, the organization will first follow the process outlined in the Heartland Workforce Investment Consortium's Interlocal Agreement, item 7, for nominating and selecting members. Nominees for Board membership must be individuals with optimum policy making authority.

To locate and identify local education/training providers within the designated workforce area, the President/Chief Executive Officer (CEO) will review, at a minimum, the websites of the Commission for Independent Education, CareerOneStop, and Employ Florida.

When more than one active local private education/training provider exists, nominations will be solicited from each of these entities. Priority will be given to providers offering education/training in local targeted industries, and for high skill, high wage occupations.

CSH's CEO will contact and conduct initial review of each known provider/nominee to confirm:

- the provider is physically located within the local workforce development area;
- the provider is actively providing education/training;
- the type of education/training being provided, including information on industryrecognized and/or post-secondary credentials to be received upon completion for each program offered, and identification of specific partnerships or collaborations the provider has established with business or industry;
- the interest, contact information, and qualifications of the nominee;
- verification that the nominee has optimum policy making authority for the provider;
- general social media and public record review of each nominee; and
- verification of provider's current Florida licensing, certification, or otherwise recognized accreditation authorizing the entity to provide training services in Florida.

Nominations of prospective members will be compiled by the CSH staff and prepared for consideration by the CSH Executive Board at its next scheduled meeting.

If CSH finds that no qualified private education/training provider exists in the designated local workforce area, CSH will submit to CSF a request to waive this requirement. The request must include a copy of this process as well as documentation of the results of efforts taken to fill the seat.
